GENERAL TERMS & CONDITIONS

- 1. The words 'SCHSL', 'We', 'Our' as used in the Limited Tender Enquiry shall mean Shelter Co-operative Housing Society Ltd. located at Flat No. 77CC/02, Anupama Housing Complex, Phase-II, VIP Road, Kolkata 700 052.
- 2. The words "Tenderer" / "Contractor" and/or "Party", "You", "Your" as used in the Limited Tender Enquiry shall mean the bidder who has submitted the quotation in response to our above Limited Tender Enquiry Ref No. SCHSL/Security/VMS/2025/70dated 16.08.2025
- **3. Title of the job:-** Contract for supply, installation, testing, commissioning, and maintenance of a fully integrated Visitors' Management System software at SCHSL's premises. It shall also inter-alia include training of security personnel and rendering technical support throughout the contract period.
- 4. Contract period: The Contract shall initially remain valid for five years, with five years of complementary service to be rendered by service provider. SCHSL, however, reserves right to extend the contract for an additional two years period at per same terms and conditions subject to mutual consent of both the parties.

- c) To integrate with existing security system:
- d) To meet legal compliance for relevant data privacy regulations and security standard.

II. Other Statutory documents:-

- I) Certificate of Registration under Companies Act 2013/Certificate under Limited Liability Partnership Act 2008 **Or** Name & Address of Board of Directors & Shareholders under Indian Partnership Act, 1932 **Or** Proof of proprietorship Firm (whichever is applicable);

III. Experience Requirement:

IV. Technical Skills:

The proposed system offered by the bidder must comply with the latest data protection and cyber security standards, including end to end encryption for sensitive data.

V. Financial Criteria:

The Tenderer must have a minimum annual turnover of Rs. 30 lakhs in each of the last three financial years. Supporting documents, such as an audited balance sheet or a certificate from a Chartered Accountant, may be provided.

9. Communication Details:
